BE IT RESOLVED, by the Council of The City of San Diego as follows:

1. That the low base bid of \$39,780.00, which is 61.7% over the City's estimate, of INSITUFORM SOUTHWEST, meeting specifications for REHABILITATION OF STORM DRAIN AT WILBUR AVENUE, in the City of San Diego, California, is hereby accepted; and the City Manager is hereby authorized to execute a contract therefore in accordance with the form on file in the Office of the City Clerk as Document No. 119558.


2. That the City Auditor and Comptroller is hereby authorized to modify the FY1991 Capital Improvements Program by adding CIP No. 11-291.0, REHABILITATION OF STORM DRAIN AT WILBUR AVENUE; and authorizing the transfer of \$49,000.00 from CIP No. 11-225.0, HILLSIDE DRIVE DRAIN, to CIP No. 11-291.0, REHABILITATION OF STORM DRAIN AT WILBUR AVENUE.

2. That the City Auditor and Comptroller is hereby authorized to transfer \$19,000.00 from the Proposition 'A' Fund No. 30300, CIP No. 17-001.0, ANNUAL ALLOCATION - MINOR DRAIN REQUIREMENTS, to CIP No. 11-291.0, REHABILITATION OF STORM DRAIN AT WILBUR AVENUE, not to exceed \$68,000.00 from Proposition 'A'

Fund No. 30300, CIP No. 11-291.0, and authorizing the Auditor and Comptroller, upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
