SHANDRICK, for TORREY PINES PEDESTRIAN OVERPASS TREATMENT PROJECT in the City of San Diego, California, is hereby accepted; and the City Manager is hereby authorized to execute a contract therefore in accordance with the form on file in the Office of the City Clerk as Document No. 119448.

2. That the City Auditor and Comptroller is hereby authorized to transfer \$65,000.00 from GAS TAX FUND 302191 to CIP No. 53-049.0, PRESERVATIVE TREATMENT OF THE TORREY PINES PEDESTRIAN OVERCROSSING.

3. That the additional expenditure of \$65,000.00 from CIP No. 53-049.0 to supplement funds previously authorized by Resolution No. R-275558, adopted April 23, 1990, is hereby authorized solely and exclusively for said project and related costs.

4. That the Auditor and Comptroller is hereby authorized, upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
