CO. are hereby accepted and the City Manager is hereby authorized  
to execute contracts for the purchase of PHOTOGRAPHIC PROCESSING  
SERVICE as may be required for a period of one (1) year beginning  
December 1, 1990 through November 30, 1991, per prices on file in  
the Purchasing Department, with options to renew the contract for  
four (4) additional one year periods, with price increases not to  
exceed 10% of the prices in effect at the end of each prior  
period, with awards as follows:

1. ONE HOUR FILM EXPRESS for Schedules I and II, Color and  
Black & White Film Processing, for an estimated annual  
cost of \$30,270.00; terms 2% 30 days.
2. COLOR CRAFT CO. for Schedule III, Custom Enlargements,  
for an estimated annual cost of \$15,520.00; terms 2% 20  
days.
