1. That the plans and specifications for the furnishing of all labor, material, tools, equipment, transportation and other expense necessary or incidental for SIDEWALK AND CURB REPLACEMENT ON VARIOUS CITY STREETS -- FY 91, filed in the office of the City Clerk of The City of San Diego, California, on JAN 09 1991, and bearing official Document No. RR- 277129 be and the same are hereby approved.

2. That the Purchasing Agent of The City of San Diego be, and he is hereby authorized and directed to proceed to publish in accordance with law, notice to contractors calling for bids for the work hereinabove described, in accordance with the plans and specifications hereinabove referred to.

3. That the City Manager is hereby authorized to execute a contract with the lowest responsible bidder for the SIDEWALK AND CURB REPLACEMENT ON VARIOUS CITY STREETS -- FY 91.

5. That the expenditure, not to exceed \$200,000.00 from the Gas Tax Fund No. 302191 is hereby authorized solely and exclusively for the purpose of providing funds for said project

upon advice from the administering department, to transfer excess  
budgeted funds, if any, to the appropriate reserves.
