1. That the plans and specifications for the furnishing of all labor, material, tools, equipment, transportation and other expense necessary or incidental for the CONSTRUCTION OF WATER AND SEWER MAIN REPLACEMENT GROUP 466, filed in the office of the City Clerk of The City of San Diego, California, on JAN 09 1991, and bearing official Document No. W.O. 170411/180321 be and the same are hereby approved.

2. That the Purchasing Agent of The City of San Diego be, and he is hereby authorized and directed to proceed to publish in accordance with law, notice to contractors calling for bids for the work hereinabove described, in accordance with the plans and specifications hereinabove referred to.

3. That the City Manager is hereby authorized to execute a contract with the lowest responsible bidder for the CONSTRUCTION OF WATER AND SEWER MAIN REPLACEMENT GROUP 466.

4. That the expenditure, not to exceed \$731,300 from the Annual Allocation for Water Main Replacement, CIP No. 73-083.0 (41502), and \$857,500 from the Annual Allocation for Sewer Main Replacement CIP No. 44-0100.0 (41506), is hereby authorized

solely and exclusively for the purpose of providing funds for said project and related costs, and authorizing the Auditor and Comptroller, upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
