- 3. That no broker's commission shall be paid by The City of San Diego on the herein described negotiated sale.

BE IT FURTHER RESOLVED, that the City Manager or his designee is hereby authorized to execute a Right of Way Contract with the STATE OF CALIFORNIA DEPARTMENT OF TRANSPORTATION, a copy of which Right of Way Contract is on file in the office of the City Clerk as Document No. RR- 277153, in connection with said portion of Lot 44, Bonnie Brae.

BE IT FURTHER RESOLVED, that the City Clerk is hereby authorized and directed to deliver the deeds and a certified copy of this resolution, attested by him under seal, to the Property Director for further handling.
