WHEREAS, the vacation of the City's interest in an unneeded sewer and drainage easements affecting Lots 27, 28, 29 and 30, Amended Map of Resubdivision of Friedrick Manor, Map No. 11808, as more particularly shown on Drawing No. 17538-B attached hereto as Exhibit A, has been requested by the affected property owners; and

WHEREAS, the owners wishes to clear title to their land of all unnecessary easements in order to permit better utilization of the property; and

WHEREAS, the herein-described easements have never been used, and are surplus to City needs; and

WHEREAS, this action is exempt from the provisions of the California Environmental Quality Act of 1970 under City guidelines for implementation of said Act, as amended; NOW, THEREFORE,


BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That pursuant to Section 8300 et seq. of the Streets and Highways Code the sewer and drainage easements, as more particularly shown on the drawing attached hereto, are hereby vacated.

2. That the City Clerk of said City be, and he is hereby authorized and directed to cause a certified copy of this

resolution, attested by him under seal, to be recorded in the
office of the County Recorder.

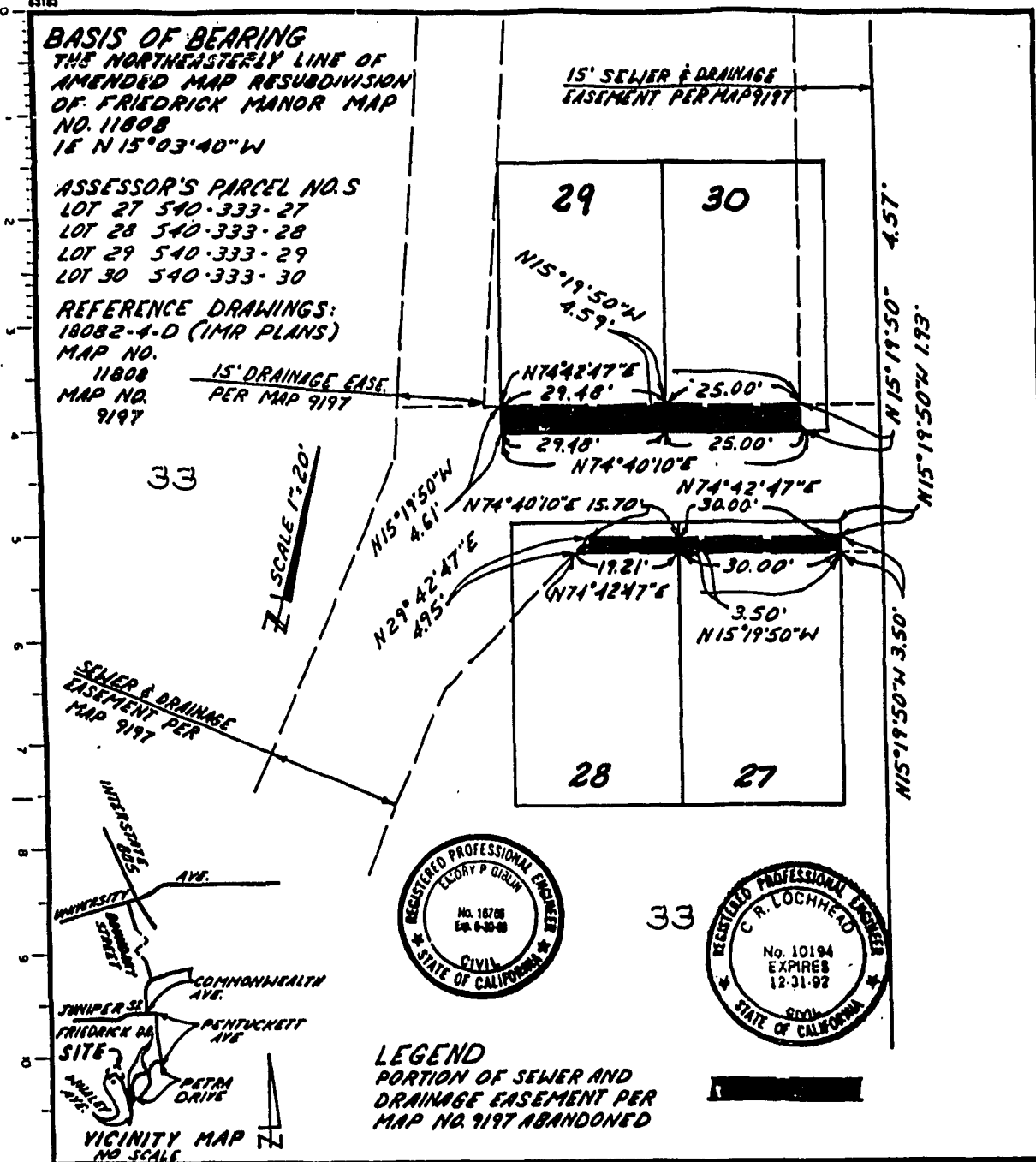
