
ADOPTED ON JAN 09 1991

Oakes Branch, under the terms and conditions set forth in the Agreement on file in the office of the City Clerk as Document No. RR- 277164, together with any reasonably necessary modifications or amendments thereto which do not increase project scope or cost and which the City Manager shall deem necessary from time to time in order to carry out the purposes and intent of this project and agreement.

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$50,000 from CIP No. 37-236.0, C.D.B.G. Fund (18526), is hereby authorized, solely and exclusively for the purpose of providing funds for the above project.
