
RESOLUTION NUMBER R- 277173

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$8,050 from Fund 100, Dept. 110, Org. 485, Object Account 4682, Job Order 111482, for lease costs from December 1, 1990, to June 30, 1991, is hereby authorized and approved.
