WHEREAS, the petition was properly filed and found to contain sufficient verified signatures of over fifteen percent (15%) of the registered voters of Council District Five (5) at the last general City election; and

WHEREAS, the Council under Municipal Code section 27.2722 must immediately call a special election; and

WHEREAS, this election shall be for the purpose of submitting to the people of District Five (5) the proposal to recall said Councilmember and, if such official is recalled, to elect a successor; and

WHEREAS, the election shall be held not less than sixty (60) days after adoption of the ordinance calling the election but not later than ninety (90) days after such adoption; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego that the City Council directs the City Attorney to prepare an ordinance placing the question on the ballot and calling a special election to be held in District Five (5) for the purpose

of submitting to the people of District Five (5) the proposal to recall said Councilmember and, if such official is recalled, to elect a successor.
