
BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of the City, an agreement with I LOVE A CLEAN SAN DIEGO COUNTY, INC., to conduct various programs to promote recycling and waste reduction throughout the City, under the terms and conditions set forth in the Agreement on file in the office of the City Clerk as Document No. RR- 277202-1, together with any reasonably necessary modifications or amendments thereto which do not increase project scope or cost and which the City Manager shall deem necessary from time to time in order to carry out the purposes and intent of this program and agreement.

BE IT FURTHER RESOLVED, that the City Manager is authorized to execute, for and on behalf of the City, an agreement with I LOVE A CLEAN SAN DIEGO COUNTY, INC., to conduct public education, information and recycling programs in support of the City's waste reduction recycling efforts, under the terms and conditions set forth in the Agreement on file in the office of the City Clerk as Document No. RR- 277202-2, together with any reasonably necessary modifications or amendments thereto which do not increase project scope or cost and which the City Manager shall deem necessary from time to time in order to carry out the purposes and intent of this program and agreement.

BE IT FURTHER RESOLVED, that the expenditure of a sum not to exceed \$224,000.00 from Fund No. 41200, Object Account 4151, is hereby authorized, solely and exclusively to fund these programs, as follows: \$84,000.00 to promote recycling and waste reduction, and \$140,000.00 in support of waste reduction recycling efforts.


