RESOLUTION OF THE CITY COUNCIL OF THE CITY OF
SAN DIEGO APPROVING PRELIMINARY OFFICIAL
STATEMENT IN CONNECTION WITH THE ISSUANCE OF
CITY OF SAN DIEGO 1991 GENERAL OBLIGATION
BONDS (PUBLIC SAFETY COMMUNICATION PROJECT)

WHEREAS, pursuant to an ordinance to be adopted by the City Council (the "City Council") of the City of San Diego, California (the "City") on January 28, 1991, the City intends to authorize the issuance of general obligation bonds to be designated "City of San Diego 1991 General Obligation Bonds (Public Safety Communications Project) (the "Bonds"), in the principal amount of \$25,500,000, to be issued in accordance with Article 1, Chapter 4, Division 4, Title 4 (commencing with Section 43600) of the California Government Code and sold for the purposes set forth in the recitals of said ordinance; and

WHEREAS, there has been submitted to the members of the City Council the form of Preliminary Official Statement to be used in connection with the issuance and sale of the Bonds;


NOW, THEREFORE, the City Council of the City of San Diego, California DOES HEREBY RESOLVE, DETERMINE AND ORDER as follows:

Section 1. Approval of Official Statement. That the Preliminary Official Statement to be used in connection with the issuance and sale of the City of San Diego 1991 General Obligation Bonds (Public Safety Communications Project), in substantially the form presented on this date and on file in the Office of the City Clerk, is hereby approved and deemed final by City Council, subject to being reproduced as the final Official Statement, and the distribution of the Preliminary Official Statement to prospective purchasers of the Bonds is hereby authorized. The Mayor is hereby authorized and directed to execute and deliver the same with such changes therein as may be recommended by bond counsel and approved by the City Manager or his designee.

Section 2. Effective Date of Resolution. This resolution shall be effective as of the date of adoption by the City Council of the ordinance authorizing the issuance of the Bonds.
