A RESOLUTION OF THE COUNCIL OF THE CITY OF  
SAN DIEGO APPROVING A REPRESENTATIVE PROJECT  
AREA COMMITTEE FOR THE NORTH PARK  
REDEVELOPMENT PROJECT AREA.

WHEREAS, the Council of The City of San Diego (the  
"Council") by Resolution No. R-276720, adopted the Procedure for  
Formation of the Project Area Committee (PAC) for the North Park  
Redevelopment Project at its October 16, 1990 meeting; and

WHEREAS, an election was held in the community in which the  
North Park Redevelopment Project is located on December 1, 1990,  
to elect the members who are to serve on the Project Area  
Committee; and

WHEREAS, an election was conducted after notice and  
according to established procedures enumerated within the  
documents approved by the City Council and a representative from  
the City Clerk's office attended the election to ensure its  
validity; and

WHEREAS, the elected members of the Project Area Committee  
have submitted to this City Council information establishing the  
qualifications of each person relative to district, category, or  
organization as appropriate; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as  
follows:

1. That the North Park Redevelopment Project Area


Committee consisting of the persons named on the list of Project Area Committee members receiving the highest number of votes attached hereto as Exhibit A and incorporated herein by this reference is hereby approved as constituting a representative Project Area Committee.

2. That the Council hereby concurs that the election results are valid and binding in accordance with the procedures so adopted by Resolution No. R-276720.

3. That the Redevelopment Agency of The City of San Diego is hereby directed to consult with and obtain the advice of the Project Area Committee concerning those policy matters which deal with the planning and provision of residential facilities or replacement housing and other matters which affect the residents of the Project Area while preparing a redevelopment plan and for a period of three (3) years after adoption of the plan.
