WHEREAS, more than one out of four of our young people will drop out of school before graduating high school; and

WHEREAS, KPBS Television and the San Diego Dropout Prevention and Recovery Round Table are organizations dedicated to the education of all students and to helping San Diego's young people lead productive lives; and

WHEREAS, KPBS Television and the San Diego Dropout Prevention and Recovery Round Table provide informative programming and support services to encourage San Diego youth to complete their education; and

WHEREAS, on January 24, 1991 at 8:00 p.m., KPBS Television will air "Before It's Too Late" a documentary examining the drop out problem from the perspective of the drop outs themselves; and


