BE IT RESOLVED, by the Council of The City of San Diego that the low bid of BAY CITY ELECTRIC WORKS, INC., meeting specifications, is hereby accepted and the City Manager is hereby authorized to execute a contract for NINE (9) GENERATORS for a total cost of \$125,243.00, plus NINE (9) OVERVOLTAGE PROTECTION PACKAGES at a cost of \$106.00 each, for a total cost of \$954.00; for an overall total cost of \$126,197.00; terms net 30 days, plus sales tax.

BE IT FURTHER RESOLVED, that the expenditure, not to exceed \$135,030.79, from Department Nos. 30244 and 820, Fund Nos. 30244 and 50030, Organization No. 400, Object Account No. 3306 and Job Order Nos. 333950 and 8257, is hereby authorized solely and exclusively for providing funds for said project and related costs, and authorizing the Auditor and Comptroller, upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.


