WHEREAS, City, acting through the City Council has since 1987 approved the San Diego Police Department's Fitness, Image, and Training Program; and

WHEREAS, the City Manager and the Chief of Police, have since October of 1989, agreed to provide treadmill testing for officers age forty (40) years and older; and

WHEREAS, a contractor, the San Diego Cardiac Center Medical Group, Inc., is ready, willing, and able to provide needed professional services under general supervision of the Chief of Police, or his designated representative for the treadmill testing of officers age forty (40) years and older, NOW THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, an agreement with The San Diego Cardiac Center Medical Group, Inc., contractor, for treadmill testing of officers age forty (40) years and older from November 1, 1990, through June 30, 1991, with options to renew contract for two (2) additional one (1) year periods, under the terms and conditions set forth in the Agreement on file in the Office of the City Clerk as document No. RR- 277236.

BE IT FURTHER RESOLVED, that the expenditure of the amount

estimated to be \$37,500 from Fund 100, Department 110,
Organization 322, Account No. 4222, Job Order 111691, is hereby
authorized, solely and exclusively for the purpose of providing
funds for the above project.
