BE IT RESOLVED, by the Council of the City of San Diego as follows:

1. That the plans and specifications for the furnishing of all labor, material, tools, equipment, transportation and other expense necessary or incidental for the CONSTRUCTION OF TRAFFIC SIGNAL AND STREET LIGHTING SYSTEMS AT FAIRMOUNT AVENUE AND OLIVE STREET, filed in the office of the City Clerk of The City of San Diego, California, on JAN 28 1991, and bearing official Document No. U.C. 119552 be and the same are hereby approved.

2. That the Purchasing Agent of The City of San Diego be, and he is hereby authorized and directed to proceed to publish in accordance with law, notice to contractors calling for bids for the work hereinabove described, in accordance with the plans and specifications hereinabove referred to.

3. That the City Manager is hereby authorized to execute a contract with the lowest responsible bidder for the CONSTRUCTION OF TRAFFIC SIGNAL AND STREET LIGHTING SYSTEMS AT FAIRMOUNT AVENUE AND OLIVE STREET.

4. That the expenditure, not to exceed \$94,000 from CIP No. 61-001.0, SIGNAL INSTALLATIONS TO ACCOMMODATE SUDDEN TRAFFIC

CHANGES, Capital Outlay Fund 30245, is hereby authorized solely and exclusively for the purpose of providing funds for said project and related costs, and authorizing the Auditor and Comptroller, upon advice from the administering department, to retain excess budgeted funds, if any, in CIP No. 61-001.0.
