RESOLUTION NUMBER R- 277253

ADOPTED ON JAN 28 1991

WHEREAS, as part of the State's budget, legislation was passed which funded several parks projects for The City of San Diego; and

WHEREAS, the East Clairemont Athletic Area was one of those projects and was appropriated \$300,000 in grants funding; and

WHEREAS, the project proposes to compliment the existing softball fields with landscaping, parking, multipurpose courts, restrooms and a play area; and

WHEREAS, a complete grant application is now required to obtain the funding; and

WHEREAS, procedures established by the State Department of Parks and Recreation for grant application require the City to certify by resolution the approval of the grant application before submission to the state; and

WHEREAS, said grant application contain assurances that the applicant must comply with, including execution of an agreement with the State of California for subject project; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That the City Manager or his representative be and he is authorized to submit an application to the California Department of Parks and Recreation in the amount of \$295,500 for development of the East Clairemont Athletic Area.


2. That the City Council certifies that it understands the assurances and certification in the application form and that it has or will have sufficient funds to operate and maintain the East Clairemont Athletic Area project.

3. That the City Council certifies that it has reviewed and understands the General Provision contained in the State/local agreement shown in the Procedure Guide.

4. That the City Auditor and Comptroller is authorized to establish a separate interest bearing account for the funds allocated to the grant project.

5. That the City Manager or his representative be and he is authorized to take all necessary actions to secure the above recited funding including execution of the grant agreement and submission of all documents including, but not limited to agreements, amendments, payment requests and other documents which may be necessary for the completion of the project recited above.
