BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$400,991.00, consisting of \$86,000.00 from Water Revenue Fund 41502 (CIP No. 70-910.1); \$80,616.00 from Sewer Revenue Fund 41506 (CIP 46-122); \$171,275.00 from Sewer Revenue Fund 41506 (CIP No. 46-117); and \$63,100.00.00 from Proposition A One-Half Percent Sales Tax Fund 30300 (CIP No. 52-330.0), is hereby authorized, solely and exclusively for the purpose of providing funds for these projects.

BE IT FURTHER RESOLVED, that the City Manager is authorized to finance or refinance these projects with tax exempt securities, if circumstances so warrant.
