RESOLUTION NUMBER R- 277261

ADOPTED ON JAN 28 1991

WHEREAS, The City of San Diego Administrative Regulation 95.25 states the policy of the City for annual review of fees to insure that all reasonable costs in providing services are being recovered; and

WHEREAS, San Diego Municipal Code section 33.4000(b), provides for the licensing and regulation of businesses which remove and store vehicles parked on private property without the consent of the property owner; and

WHEREAS, the licensing fee which authorizes Private Property Vehicle Tows has been reviewed and a fee increase from one hundred (\$100) dollars annually to four hundred and thirteen (\$413) dollars annually is needed in order to recover costs; and

WHEREAS, Licensees were notified of the proposed fee revision through a direct mailing to thirty-five (35) licensees;
NOW THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager is hereby authorized to increase from one hundred (\$100) dollars annually to four hundred and thirteen (\$413) dollars annually the licensing fee which authorizes

Private Property Vehicle Tows, the exact amount of which shall be maintained in the City Clerk's composite rate book pursuant to San Diego Municipal Code section 33.3706.
