
ADOPTED ON JAN 28 1991

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, an agreement with Luth & Turley, Inc., for general reconstructive and cleanup work for damage to private property as outlined in Council Policy 400-10 and damages to property for which the City may be responsible, under the terms and conditions set forth in the Contract on file in the office of the City Clerk as Document No. RR- 277266, together with any reasonably necessary modifications or amendments thereto which do not increase the scope or cost of this contract and which the City Manager shall deem necessary from time to time in order to carry out the purposes and intent of this contract.

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$627,624.00, consisting of \$249,794.00 from Water Utilities Water Fund 41500 and \$377,830.00 from Sewer Fund 41506, is hereby authorized, solely and exclusively for the purpose of providing funds for the above contract.
