RESOLUTION NUMBER R- 277280

ADOPTED ON JAN 29 1991

WHEREAS, on January 23, 1991, the Rules Committee reviewed Report No. 91-1 from the Department of Legislative Services (DLS) regarding a proposed supplement to the City of San Diego's Legislative Sponsorship Program; and

WHEREAS, the Rules Committee reviewed the proposed legislation relating to the statute of limitations on asbestos damage previously sponsored by the City, passed by the legislature and vetoed by the Governor for inclusion in the 1991 Legislative Sponsorship Program; and

WHEREAS, after discussion of the sponsorship proposal, the proposal was assigned to the Rules Committee for monitoring during the legislative process; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the Council hereby approves the recommendation of the Department of Legislative Services that legislation relating to the statute of limitations on asbestos damage previously sponsored by The City of San Diego be authorized for incorporation into the 1991 State Legislative Sponsorship Program.

BE IT FURTHER RESOLVED, that this legislative proposal be assigned to the Rules Committee for monitoring of its progress

during the legislative session.
