

RESOLUTION NUMBER R- 277284

ADOPTED ON JAN 29 1991

WHEREAS, the City Council of The City of San Diego has reviewed and considered City Planning Director's Reports 90-378 and 91-030 and the recommendations contained therein; and

WHEREAS, the City Council has further introduced amendments to the Resource Protection Ordinance (RPO) contained in San Diego Municipal Code section 101.0462, in furtherance of those recommendations; and

WHEREAS, those recommendations also include the adoption of a Council policy on long range planning and certain updated Federal Emergency Management Assistance (FEMA) maps; and

WHEREAS, the City Planning Director has submitted to the Council proposed administrative guidelines for consideration in connection with the administration of the Resource Protection Ordinance; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That the City Council hereby adopts the replacement FEMA maps as recommended by the City Planning Director, and hereby designated as Documents No. RR- 277284-1-43

2. The City Clerk shall enter the above document designation into subsection C.1 of San Diego Municipal Code section 101.0462 upon the effective date of the adoption of the amendments to that section;



3. That the proposed Council policy on long range planning recommended by City Planning Director Report No. 90-378 is hereby adopted, and the City Clerk is directed to promulgate said policy as Council Policy No. 600-40 and to insert said number into subsection D.4 of San Diego Municipal Code section 101.0462 upon the effective date of the adoption of the amendments to that section;

4. That the administrative guidelines recommended by and contained within City Planning Director Report No. 90-378 as Attachment 3, are hereby considered appropriate for promulgation upon the effective date of the amendment to San Diego Municipal Code section 101.0462, which provides therein for such promulgation;

5. That further amendments to said administrative guidelines which conform to and implement the provisions of San Diego Municipal Code section 101.0462 may be made thereafter by the City Planning Director and promulgated without further reference to this Council in accordance with said provisions of section 101.0462, as amended;


6. That the City Planning Director shall further form a technical advisory committee to monitor the implementation of the Resource Protection Ordinance and its amendments and report back to this Council and the Transportation and Land Use Committee and Planning Commission, as shall be appropriate, the conclusions of the City Planning Director respecting the results for the first six months of the amendments to the Resource Protection Ordinance and the policies and guidelines promulgated in furtherance thereof in meeting the purposes and intent of such ordinance;

7. That the Planning Director and City Manager shall prepare a Policy for Council approval concerning the criteria and review of Public Works Projects within the context of the Resource Protection Ordinance;

8. That the Planning Director shall prepare a report for City Council consideration within 90 days regarding the scope of the provisions and restrictions upon sand and gravel operations contained in RPO.
