WHEREAS, The City of San Diego is committed to upgrading the Metropolitan Sewerage System; and

WHEREAS, the process of upgrading the system necessitates construction projects which will traverse or occupy lands held by the United States Navy under exclusive federal jurisdiction; and

WHEREAS, these projects may include, among others, replacement of sludge transmission pipelines from the Point Loma Wastewater Treatment Plant and expansion of the Point Loma Wastewater Treatment Plant; and

WHEREAS, the United States Navy, in the spirit of intergovernmental cooperation and for valuable consideration, will be granting easements and other land interest transfers required to complete these construction projects; and

WHEREAS, the United States Navy has expressed concern regarding the inability of local law enforcement agencies to take enforcement action on streets and highways under exclusive federal jurisdiction; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the City supports a retrocession of legislative jurisdiction by the United States Navy to the State of California pursuant to Section 77.5 of the California Streets and Highways Code over those portions of real property situated in the County of San Diego, upon which easements or rights-of-way currently exist for Cabrillo Memorial Drive southerly to the intersection with

Cabrillo Road, Cabrillo Road southerly to the intersection with Gatchell Road, and Gatchell Road northerly to the Point Loma sewage treatment plant, thereby enabling enforcement activity by state and local law enforcement agencies upon those streets and highways.

BE IT FURTHER RESOLVED, that the City Manager is authorized to make a written request of the United States Navy to initiate the retrocession process in accordance with the provisions of Section 77.5 of the California Streets and Highways Code.
