BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is hereby authorized to transfer an amount not to exceed \$177,172 from Capital Outlay Grant Fund 38500 to CIP No. 63-010.0 "Signal Timing Optimization Program, Phase Seven."

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$177,172 from CIP No. 63-010.0, is hereby

authorized, solely and exclusively for the purpose of providing funds for the above project.
