WHEREAS, the state Department of Justice maintains an automated system for retaining and identifying fingerprints known as the California Identification System (Cal-ID); and

WHEREAS, the San Diego County Sheriff's Department is the county's proprietary agency for San Diego County's California Identification System/Remote Access Network (Cal-ID/Ran); and

WHEREAS, the San Diego Police Department desires to continue participation in Cal-ID/Ran; NOW THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, an agreement with the County of San Diego to operate the California Identification System Remote Access Network (Cal-ID/Ran) for a term of five (5) years from July 1, 1990, to June 30, 1995, subject to annual appropriation of funds by the San Diego City Council.
