WHEREAS, a vacancy exists on the San Diego Unified Port District Board of Commissioners, effective January 3, 1991, because of the expiration of the term of Lynn Schenk; and

WHEREAS, the Mayor and each Councilmember have had the opportunity to submit proposed nominees for appointments to those vacancies; and

WHEREAS, it is recommended that Lynn Schenk be reappointed to the Unified Port District Board of Commissioners to fill the vacancy, effective January 3, 1991, for a four-year term; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that after full and complete public discussion and deliberation, Lynn Schenk be and she is hereby reappointed to serve as a member of

the San Diego Unified Port District Board of Commissioners for a
four-year term expiring January 2, 1995.
