WHEREAS, in the early 1970s, when land use planning efforts began for the community, North City West was given its name to differentiate it from the rest of north city; and

WHEREAS, during the past several years, the North City West Community Planning Board has received input from North City West community residents suggesting that the name of the community be changed from its current generic geographical designation to something that better reflects the character of the area; and

WHEREAS, the North City West Community Planning Board, in recognition of these suggestions, has recommended that the community name be changed from North City West to Carmel Valley; and

WHEREAS, this recommendation was set forth in Planning Department Report No. 91-016, dated January 17, 1991 and considered by the Rules Committee on January 23, 1991 and approved by a 4-0 vote; and

WHEREAS, the matter is now forwarded to the full Council with a recommendation to approve the change; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the recommendation set forth in Planning Department Report No. 91-016, dated January 17, 1991 and approved by the Rules

Committee on January 23, 1991 to change the name of the North
City West Community to Carmel Valley Community, be and the same
is hereby approved.
