RESOLUTION NUMBER R- 277321

ADOPTED ON FEB 05 1991

WHEREAS, recent federal and state anti-drug legislation has been adopted which provides additional penalties for anyone convicted of drug trafficking within a "school zone;" and

WHEREAS, The City of San Diego and County of San Diego have convened a drug summit to achieve the goals set forth in the Drug Free Bill of Rights; and

WHEREAS, a Drug Free Zone Coalition has been formed to eradicate drug trafficking along the entire length of the El Cajon Boulevard Corridor; and

WHEREAS, the Community Connection Resource Center, a nonprofit agency which provides reentry services for ex-offenders, has received support from the City and County of San Diego and is responsible for organizing the El Cajon Boulevard Drug Free Coalition; and

WHEREAS, the entire El Cajon Boulevard Community, which includes residents, merchants, schools, churches, business improvement districts, and other neighborhood organizations has joined forces to support the coalition and its fight against drugs; and


WHEREAS, in order to support the El Cajon Boulevard Drug Free Coalition and Drug Free Bill of Rights, a "Boulevard Walk" and rally at Wilson Junior High School Athletic Field will take place on February 9, 1991 and Drug Free Community Forum will be held at Hoover High School on February 23, 1991; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that Saturday, February 9, 1991 be observed as "EL CAJON BOULEVARD DRUG FREE ZONE DAY" in The City of San Diego.

BE IT FURTHER RESOLVED, that the City Council will vigorously support the pledge found in the Drug Free Bill of Rights and will continue our nation's ongoing war against drugs.
