WHEREAS, the Suggestion Awards Committee has heretofore made certain recommendations to this Council; and


WHEREAS, the Council has reviewed said recommendations as well as the suggestions as presented; NOW, THEREFORE,

This is a full award based on the estimated first year savings of \$499.14.

AMOUNT: \$99.46  
SUGGESTION: Mr. Guthrie is Equipment Technician II with the Property Department. He suggested the use of grease zerks on Toro 322D1 and lawn mowers. Implementation of his suggestion resulted in a first year savings of \$663.08. This is the remainder of his award.
