



BE IT RESOLVED, by the Council of The City of San Diego, that the expenditure of an amount not to exceed \$20,890 from Gas Tax Fund 32191, C.I.P. 37-028, Annual Allocation, Undergrounding of City Utilities, is hereby authorized, solely and exclusively, for payment to San Diego Gas & Electric Company for the purchase and installation of five new street lights to replace existing pole mounted street lights in the GOVERNOR DRIVE (GENESEE AVENUE TO GULLSTRAND STREET) UNDERGROUND UTILITY DISTRICT, minor City force work and other related work.
