BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager is hereby authorized and empowered to execute, for and on behalf of said City, an agreement with BSI Consultants, Inc. for engineering services in connection with improvements to sewer pump station 20, under the terms and conditions set forth in the Agreement on file in the office of the City Clerk as Document No. RR-277343, together with any reasonably necessary amendments or modifications thereto which do not increase the project's scope or cost which the City Manager shall deem necessary from time to time in order to carry out the purposes and intent of this project and agreement.


BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is hereby authorized to transfer an amount not to exceed \$84,646.00 within Sewer Revenue Fund 41506, Sewer Construction Outlay (70492), from CIP 46-162.0, East Linda Vista Trunk Sewer, to CIP 46-106.0, Annual Allocation for Sewer Pump Station Restoration.

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$84,646.00 from Sewer Revenue Fund 41506, CIP 46-106.0, Annual Allocation for Sewer Pump Station Restoration, is hereby authorized, solely and exclusively to provide funds for the above project.

BE IT FURTHER RESOLVED, that the City Manager is authorized to finance or refinance this project with tax exempt securities, if circumstances so warrant.
