RESOLUTION NUMBER R-277352

ADOPTED ON FEB 11 1991

WHEREAS, the City Council on August 10, 1987 adopted Policy No. 000-50 "Emergency Response Plan for the Homeless;" and

WHEREAS, the City Council has determined it is necessary from time to time to open emergency shelters to house the homeless during periods of life-threatening cold; and

WHEREAS, the City Council desires to establish the temperature and conditions when emergency shelters will be provided; and

WHEREAS, the need for emergency shelter accommodations has been projected to exceed the ability of the City to meet said need through use of City facilities; and

WHEREAS, the San Diego Housing Commission has some present capability of providing funds to secure adequate shelter space for the homeless during emergency conditions; NOW, THEREFORE,


BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager, in cooperation with San Diego Housing Commission staff, shall solicit, through a competitive process, a provider or providers for shelter space during the remainder of the current winter season to accommodate the homeless when temperatures reach 40 degrees or below, or 50 degrees or below when one-half inch of rain is predicted.

BE IT FURTHER RESOLVED, that the Housing Authority be requested to identify adequate funding for this effort.

BE IT FURTHER RESOLVED, that the Housing Authority be requested to authorize the Housing Commission to enter into appropriate agreements as may be required to implement the opening of emergency shelters, and to authorize the expenditure of said funds for this purpose.
