RESOLUTION NUMBER R- 277362

ADOPTED ON FEB 12 1991

WHEREAS, Southern California Edison Company and San Diego Gas & Electric Company announced their intention to merge in November 1988; and

WHEREAS, this City Council has determined to oppose this proposed merger and has instructed the City Attorney to represent the City accordingly in certain proceedings before the Federal Energy Regulatory Commission ("FERC") and the California Public Utilities Commission ("CPUC"); and

WHEREAS, on November 27, 1990 FERC Administrative Law Judge George P. Lewnes, issued an initial decision that the proposed merger be denied; and

WHEREAS, on February 1, 1991 CPUC Administrative Law Judges Lynn T. Carew and Brian T. Cragg, issued a proposed decision that the proposed merger be denied; and

WHEREAS, these Commissions will, in due course, consider the decisions of their respective ALJs in regular meetings; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that this City Council fully supports the decisions made by the FERC and CPUC Administrative Law Judges to deny the proposed merger.

BE IT FURTHER RESOLVED, that this City Council urges the CPUC to hold in San Diego, California the oral arguments now scheduled for March 6, 1991, and urges the FERC, if it decides to


