WHEREAS, Joan B. Kroc has followed the credo of her late husband, Ray A. Kroc, founder of McDonald's Corporation: "Give Something Back to the Community," and she has sought to make a difference by supporting issues of social significance locally, nationally and internationally; and

WHEREAS, Joan, working with her late husband, owned and built the San Diego Padres baseball franchise into a pennant contending team that made its first World Series appearance in 1984; and

WHEREAS, Joan founded Operation Cork to create awareness of chemical dependence and its impact on the family; formed the Joan B. Kroc Foundation to address issues including substance abuse, world hunger, world peace, and care for the terminally ill; and made gifts totaling more than \$5 million to support AIDS research and provide care to persons with the disease; and

WHEREAS, Joan has been recognized for her achievements with honorary doctorates from the Universities of Notre Dame and San Diego; the Gold Key Award of the National Council on Alcoholism; the Medal of Honor of the Daughters of the American Revolution; the California League of Women Voters' Carrie Chapman Catt Award; a Bronze Medal from the Society for the Family of Man; the St. Jude Children's Hospital's Woman of the Year Award, and the Neil H. Jacoby Award from UCLA; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that this Council, for and on behalf of the people of San Diego, does hereby commend Mrs. Joan B. Kroc for the leadership, spirit, and the inspiration with which she has infused our city, and further declares that San Diego has truly benefited from her faith, strength of vision, depth of humanity, and her devotion to the betterment of mankind.
