BE IT RESOLVED, by the Council of The City of San Diego that the low acceptable bid of BLUE SKIES LANDSCAPE MAINTENANCE is hereby accepted and the City Manager is hereby authorized to execute a contract for furnishing COMPLETE LANDSCAPE MAINTENANCE OF DESIGNATED BUFFER ZONES, RIPARIAN OPEN SPACE, AND SIDEWALKS WITHIN THE FIRST SAN DIEGO RIVER IMPROVEMENT PROJECT (FSDRIP) LANDSCAPE MAINTENANCE DISTRICT as may be required for a period of twelve (12) months beginning September 1, 1990 through August 31, 1991 per prices on file in the Purchasing Department, for a total estimated annual cost of \$67,016.04, with terms of net 30 days, with options to renew the contract for four (4) additional one (1) year periods, with option period price increases not to exceed the prices in effect for the previous contract period by more than 10%.

BE IT FURTHER RESOLVED, that, in the event the Contractor does not perform to specifications, the Purchasing Agent is hereby authorized to terminate the contract and award to the next low responsive and responsible bidder and to subsequent bidders, if necessary, until a bidder is found who performs to specifications.
