RESOLUTION NUMBER R- 277393

ADOPTED ON FEB 19 1991

WHEREAS, the National Institute of Municipal Law Officers (NIMLO) is an international association consisting of Chief Legal Officers of governmental agencies, primarily municipalities; and

WHEREAS, NIMLO conducts various seminars, conferences and workshops during the year but conducts only one annual conference; and

WHEREAS, said annual conference attracts approximately 650 legal officers from around the United States and Canada with 350-400 spouses and children accompanying; and

WHEREAS, San Diego hosted the annual NIMLO conference in 1986 and was pronounced by all attendees as a huge success; and

WHEREAS, the conference extends over a four-day period and impacts the hotel industry, the local economy, the transient occupancy tax and the tourist reputation of San Diego; and

WHEREAS, Council, by Resolution No. R-275027, adopted on January 22, 1990, approved submission of a hosting proposal for the year 1993 but said hosting was awarded to Nashville, Tennessee; and


WHEREAS, because of unanticipated scheduling problems, NIMLO is presently processing bids for conference hosting for the latter part of 1991 and requires such bids to come through the member City's Chief Legal Officer; and

WHEREAS, the City Attorney is now requesting authorization to submit a bid to NIMLO to host the 1991 annual conference in San Diego during the month of October; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that this Council, for and on behalf of said City, hereby approves and supports the bid and commitment therein submitted by the City Attorney to host the 1991 annual conference of the National Institute of Municipal Law Officers in San Diego.

BE IT FURTHER RESOLVED, that the City Council urges the National Institute of Municipal Law Officers to accept the host bid and return to San Diego in 1991.


