BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, a second amendment to the agreement of September 25, 1989 with Joseph Wong Design Associates, Inc., for consultant services in connection with Mission Trails Regional Park Visitors Center Phase I, under the terms and conditions set forth in Amendment No. 2 on file in the office of the City Clerk as Document No. RR- 277385, together with any further modifications or amendments thereto which do not increase the project's scope or cost and which the City Manager shall deem necessary from time to time in order to carry out the purposes and intent of this project and amendment.

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$304,532 from CIP 29-680, Mission Trails Regional Park Visitors Center Phase I, Mission Trails Regional Park Fund 10580, is hereby authorized, solely and exclusively for the purpose of providing funds for the above project.
