APPROVING PARCEL MAP W.O. NO. 900723.

BE IT RESOLVED, by the Council of The City of San Diego, that said Council hereby finds that certain parcel map surveyed by Robert G. Schoettmer, Licensed Land Surveyor, entitled "PARCEL MAP W.O. NO. 900723 being lot line adjustment of Lots 4, 5, 8, 9 and 10 of Mesa Shopping Center East Unit Nos. 1 & 2, in the City of San Diego, County of San Diego, State of California, according to map thereof No. 12628, recorded April 26, 1990," is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said parcel map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public, the following: a portion of Mira Mesa Boulevard, and said portion of a public street is hereby declared to be a portion of a public street and dedicated to the public use, as dedicated and shown on the map and subject to the conditions set forth thereon.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego any and all abutters' rights of access in and to Mira Mesa Boulevard, adjacent and contiguous to Parcel 5, all as shown on this map within this subdivision.


BE IT FURTHER RESOLVED, that the Clerk of said City is hereby authorized and directed to endorse upon said parcel map,

as and for the act of the Council and that said Council has approved said parcel map, and that said portion of a public street is accepted on behalf of the public as heretofore stated; together with those certain abutters' rights of access, all as granted and shown on this map within this subdivision, are accepted on behalf of The City of San Diego, a municipal corporation, as above stated.

BE IT FURTHER RESOLVED, that the Clerk of said City is hereby directed to transmit said parcel map to the County Recorder of the County of San Diego, California.
