BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager is hereby authorized and empowered to execute, for and on behalf of the City, an amendment to the agreement of July 15, 1985, with the Western Consortium for Public Health, to evaluate potential health risks associated with the total resource recovery (aquaculture) program, under the terms and conditions set forth in Amendment No. 1 on file in the office of the City Clerk as Document No. RR-277413, together with any further modifications or amendments which do not increase project scope or cost and which the City Manager shall deem necessary from time to time in order to carry out the purposes and intent of this project and amendment.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is hereby authorized to transfer an amount not to exceed \$1,204,860 within the Sewer Revenue Fund (41506), from CIP 46-111.0, Rose Canyon Trunk Sewer, to CIP 46-151.0, San Pasqual Water Reclamation Facility, and an amount not to exceed \$1,204,860, within the Water Revenue Fund (41502), from CIP 73-248.0, Pomerado Pipeline, to CIP 73-290.0, San Pasqual Water Reclamation Facility.

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$2,409,720, consisting of \$1,204,860 from Fund 41506, CIP 46-151.0, and \$1,204,860 from Fund 41502, CIP 73-290.0, is hereby authorized, solely and exclusively to provide funds for the above amendment.

BE IT FURTHER RESOLVED, that the City Manager is authorized to finance or refinance this project with tax exempt securities, if circumstances so warrant.
