BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager is hereby authorized and empowered to execute, for and on behalf of The City of San Diego, a five-year concession agreement with PEOPLEFEEDERS, INC., for the use of specified locations within Balboa Park for the sale of food, candy, confections, tobacco, beverages, and souvenirs, with a minimum rent of \$275,000 per year or 22 percent of gross income, whichever is greater, under the terms and conditions set forth in that concession agreement on file in the office of the City Clerk as Document No. RR- 277414 .
