WHEREAS, on February 20, 1991, the Committee on Rules, Legislation and Intergovernmental Relations reviewed and approved the Department of Legislative Services Report No. 91-8, dated February 13, 1991, with the exception of the repeal of sales and use tax exemptions on newspapers, as set forth in item no. 3 of the report; and

WHEREAS, in respect to item no. 3 of the report, the Rules Committee voted unanimously to forward the matter to the full Council for determination thereon; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that this Council, for and on behalf of said City, hereby supports SB 169 (Boatwright), SB 61 (C. Green), SB 63 (Kopp), SB 72 (Davis), AB 26 (Lancaster), AB 132 (McClintock); Oppose SB 203 (Maddy); and support SB 1x (Boatwright), SB 2x (Boatwright), SB 5x (Deddeh), SB 29 (Boatwright) and SB 30 (Boatwright) except the repeal of sales and use tax exemptions on newspapers.

BE IT FURTHER RESOLVED, that the Department of Legislative Services and the City Manager are hereby directed to work with the Governor and the Legislature to provide constructive

assistance in resolving the short term deficit and long term need  
to revise the state and local fiscal process.
