RESOLUTION NUMBER R- 277431

ADOPTED ON FEB 26 1991

WHEREAS, the San Diego Affordable Housing Conference, held September 29, 1989, drew attention to the housing crisis, generated new energy in the search for solutions and resulted in several housing initiatives; and

WHEREAS, the City supports the creation of communities where all San Diegans can afford to live and work; and

WHEREAS, the inadequate supply of affordable housing in developing parts of the City means that many jobholders must now commute long distances to get to work and others, without transportation, cannot access the new jobs being created in developing areas; and

WHEREAS, this exacerbates the problems of traffic congestion and air pollution, increases demands on open space and public capital for highway development, and restricts the labor pool for employers; and

WHEREAS, some companies are choosing not to locate or expand in San Diego because there is inadequate supply of affordable housing, or because such housing is too remote; and

WHEREAS, the City recognizes the need to improve the jobs-housing balance and increase the availability of affordable housing in all parts of the City to maintain the economic health of the region and our quality of life; and


WHEREAS, the amount of needed housing cannot be provided

without forging a strong cooperative spirit between lenders,  
private developers, nonprofit organizations and public agencies;  
and

WHEREAS, a planning committee representing a broad cross  
section of San Diego's interests has scheduled a second  
Affordable Housing Conference to be held on March 1, 1991; NOW,  
THEREFORE,

BE IT RESOLVED, that the City Council of The City of San  
Diego, hereby declares March 1, 1991, as "AFFORDABLE HOUSING  
DAY," and urges public officials, representatives from the  
community and the housing industry to join together in the search  
to find ways to create more livable communities where all San  
Diegans can afford to live and work.
