BE IT RESOLVED, by the Council of The City of San Diego, that the low bid of BLUE SKIES LANDSCAPE MAINTENANCE, is hereby accepted and the City Manager is hereby authorized to execute a contract for COMPLETE LANDSCAPE MAINTENANCE OF DESIGNATED LANDSCAPED CENTER ISLANDS, DEVELOPED AND UNDEVELOPED OPEN SPACE AREAS, STREET RIGHTS-OF-WAY, DEVELOPED AND UNDEVELOPED PARKS AND MAINTENANCE, AND EASEMENT BANKS IN THE SCRIPPS RANCH LANDSCAPE MAINTENANCE DISTRICT as may be required for a period of one (1) year beginning March 1, 1991 through February 29, 1992, per prices on file in the Purchasing Department, for a total estimated annual cost of \$95,115.16; terms 1% 20 days, with options to renew contract for four (4) additional one (1) year periods with increases not to exceed 10% of the prices in effect in each prior period.

BE IT FURTHER RESOLVED, that in the event the Contractor does not perform to specifications, the Purchasing Agent is hereby authorized to terminate the contract and award to the next low responsive and responsible bidder and to subsequent bidders, if necessary, until a bidder is found who performs to specifications.
