WHEREAS, the Council has reviewed said recommendations as well as the suggestions as presented; NOW, THEREFORE,



DEPARTMENT: Water Utilities/Metro Division
AMOUNT: \$50.00 (shared)
SUGGESTION: Ms. Benson is a Senior Waste Water Operations Supervisor and Mr. Gilbreath is a Senior Plant Technician Supervisor with the Metro Division. They suggested replacing the opaque odor tower covers with clear covers to better monitor media conditions. This is the maximum intangible operational award for two Category II suggesters.
