RESOLUTION AMENDING THE CONFLICT OF INTEREST
CODE FOR THE CITY OF SAN DIEGO'S DEPARTMENT OF
WATER UTILITIES.

WHEREAS, by Resolution No. R-218260, adopted on April 27, 1977, the City Council adopted a Conflict of Interest Code for the City's Department of Water Utilities pursuant to the Political Reform Act of 1974, as amended; and

WHEREAS, by Resolutions No. R-264702, adopted on December 16, 1985, and No. R-275321, adopted on March 19, 1990, the City Council adopted amendments to the Water Utilities Department's Conflict of Interest Code to reflect changes in disclosure categories.

WHEREAS, the Political Reform Act, Government Code section 81000 et seq., requires state and local government agencies to amend conflict of interest codes as needed to reflect current law and disclosure categories; and

WHEREAS, since the Department of Water Utilities Conflict of Interest Code was adopted in 1977, the Fair Political Practices Commission has adopted a regulation, 2 Cal. Code of Regulations section 18730, which contains the terms of a standard conflict of interest code and which reflects the current laws and regulations; and

WHEREAS, this standard code can be incorporated by reference and may be amended by the Fair Political Practices Commission after public notice and hearings to conform to amendments in the Political Reform Act; and

WHEREAS, the job titles and duties of various employees in the Department of Water Utilities have changed since it was last amended in March 1990, thereby causing the disclosure categories of the Department of Water Utilities to change since the Department's Conflict of Interest Code was first adopted in 1977; and

WHEREAS, the conflict of interest laws and regulations have also changed since 1977; NOW, THEREFORE,

BE IT RESOLVED, that the terms of 2 Cal. Code of Regulations section 18730 and any amendments to it duly adopted by the Fair Political Practices Commission are hereby incorporated by reference (Attachment A) and, along with the attached Appendices A and B, in which employees and consultants are designated and disclosure categories are set forth, constitute the Conflict of Interest Code of the Department of Water Utilities.

BE IT FURTHER RESOLVED, that pursuant to section 4(A) of the Conflict of Interest Code, designated employees shall file a Statement of Economic Interests (SEI's) with the City Clerk.

BE IT FURTHER RESOLVED, that this Conflict of Interest Code shall become effective immediately upon adoption by the City Council.

BE IT FURTHER RESOLVED, that the Conflict of Interest Code adopted by Resolution No. R-218260 on April 27, 1977, and as amended by Resolution Nos. R-264702, adopted on December 16, 1985, and R-275321 adopted on March 19, 1990, governing the Department of Water Utilities is hereby superseded and Resolutions Nos. R-218260, R-264702 and R-275321 are hereby rescinded.
