
RESOLUTION NUMBER R- 277451

ADOPTED ON MAR 04 1991

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, a first amendment to the agreement with AETNA HEALTHCARE PROGRAMS OF CALIFORNIA, INC., dba CHOICE, a copy of which is on file in the office of the City Clerk as Document No. RR- 277451, to extend the agreement for a one-year period beginning August 1, 1990 through July 31, 1991, increase the physician services copayment from \$3 to \$5 per office visit, eliminate the Open Choice physician feature, reduce the copayments for Inpatient and Outpatient psychiatric services from \$100 to \$0 and \$25 to \$20 respectively, reduce the Durable Medical Equipment copayments from 50% to 20%, increase the maximum out-of-pocket expense from \$750 to \$1,000, and to authorize a premium rate increase as follows:
