
BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager is hereby authorized and empowered to execute, for and on behalf of said City, an agreement with Camp Dresser & McKee, Inc., for professional services in connection with Water Main Replacement Group 508, under the terms and conditions set forth in the Agreement on file in the office of the City Clerk as Document No. RR- 277453, together with any reasonably necessary amendments or modifications thereto which do not increase project scope or cost and which the City Manager shall deem necessary from time to time in order to carry out the purposes and intent of this project and agreement.

BE IT FURTHER RESOLVED, that the expenditure of an amount not to exceed \$205,969.00 from Water Revenue Fund 41502, CIP 73-083, Annual Allocation - Water Main Replacements, is hereby authorized, solely and exclusively to provide funds for the above agreement.

BE IT FURTHER RESOLVED, that the City Manager is authorized to finance or refinance this project with tax exempt securities, if circumstances so warrant.
