WHEREAS, this PAL program is funded in part by The City of San Diego through the Seized and Forfeited Asset Funds; and

WHEREAS, The City of San Diego wishes to allow PAL more flexibility in administering its youth programs; NOW THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager is hereby authorized and empowered to execute, for and on behalf of said City, an agreement with the San Diego Police Athletic League to provide funding for programs provided through June 30, 1991, and that said agreement may be renewed annually, subject to annual appropriation of funds by The City of San Diego and the mutual agreement of both parties.
