
ADOPTED ON MAR 04 1991

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, a cooperative agreement with the City of National City, for the design and construction of a traffic signal at the intersection of 43rd Street and Delta Street, under the terms and conditions set forth in the Agreement on file in the office of the City Clerk as Document No. RR- 277456.

BE IT FURTHER RESOLVED, that the expenditure of 50% of the total contract, but an amount not to exceed \$55,000 from C.I.P. 68-001, Fund 30219 "Cooperative Signal Projects," is hereby authorized, solely and exclusively for the purpose of providing funds for the above project.
